In order to qualify you must comply with the following requirements:

TERMS

- 1- You must have a valid Independent Distribution and Promotion Agreement with the company 000 Omnilife, which must remain valid for the duration of the qualification period(s).
- 2- These terms will apply from April 1st to 31st June of 2017; for each monthly period, Leaders who have not previously participated and won the prize are eligible to participate. The last period in which participation for this bonus will be enabled is the month of June 2017.
- 3- This qualification comprises 3 consecutive monthly periods, which will be referred as "Qualification Period".
