## International Trip Dubai-Mumbai 2018

Air transportation: Omnilife reserves the right to assign the departure airport.

Ground transportation: Airport-Hotel-Airport.

Lodging: 12 cruise nights.

Food: All food while aboard within the Omnilife designated in the restaurants and consumption centers.

## **Requirements:**

- 1- Have entered into a contractual agreement as an Independent Distributor with Omnilife USA, Inc. Contract must remain valid throughout the qualification period.
- 2- You must register to participate in this Competition, the monthly periods, the required scores and the registration code, are specified in the "Target Table ", verify the one that corresponds to you.
- 3- The points may be national and international, considering the following:
